

The Opticians of Manitoba 2008 License Renewal Application

“Every person who holds a valid and subsisting license to practice Ophthalmic Dispensing in Manitoba under this Act for any year, may annually, on or before the fifteenth day of December in that year, apply to the Registrar for the renewal thereof for the next ensuing year, and renewal shall be issued upon payment of the prescribed fee. A.M.R.S.M. c191,s.16.” Section 18 of the Opticians Act requires all information on this form be completed and returned in order for you to be considered licensed in the Province of Manitoba for the year 2008.

This form must be completed in its entirety even if the information provided in previous years has not changed. If the form is not completed it will be returned for completion, and a \$15.00 administration fee will be applied.
